The information in this report for fiscal year 2023 (June 1, 2022 to June 30, 2023) represents the second year of the Recovery Partners of Vermont. Our legal name remains Vermont Recovery Network but two years ago we went through a major overhaul of how we operate and, in this report, you will begin to see the fruits of our collective labor. All of the 2023 fiscal year's accomplishments highlight why we have the word Partners in our name. Only because of a collective team effort were we able to accomplish so much in one 12-month period.

When you think of putting on a conference and making a bold announcement that it will be free to all member organizations, their staff, board, and community partners, you know that it takes a team effort. And team effort it was! From the staff of Recovery Partners of Vermont to the Conference Committee members and our stellar Conference Manager Peter Edwards, we made it happen in a big and successful way. The evaluations were humbling!!! That alone would have been quite an accomplishment for any given year but noooooo we immediately pivoted and held a successful Legislative Breakfast and, with the help from the Action Circles team, we went on to gain the support of the Vermont State Legislature to increase base funding for many of our member recovery organizations by \$2,600,000 to be used for competitive staff wages and benefits. Neither of which our members ever had. Then there was the amazing private donor who granted us funds to pay the employer match for all full- and part-time employees so that our member recovery organizations could have dental and eye care insurance for the first time!!

Above were just a few of the many accomplishments of this past year. Our members have all been hard at work rebounding from the COVID-19 pandemic while continuing to do all they can to save lives of those that have an alcohol/substance use disorder. It has been tough. The Emergency Department Program has had a tremendous positive impact on getting people who meet with one of our recovery coaches to see treatment as an option in their life. We have given out countless Harm Reduction Bags that have fentanyl strips and Narcan to hopefully save lives for those that are still in active use of drugs. Our direct service members are at the job 365 days of the year, and there is no greater work than they do to both save and help rebuild the lives of thousands of Vermonters. Recovery is the Answer! Peer Support is the Way! is more than our conference title. It is the most powerful way to a new life in recovery. That is what we do. Enjoy browsing through our 2023 Annual Report.



- Through the Law Enforcement grant, we have been able to develop a true working relationship with our local law enforcement agencies-Vermont State Troopers (VSP) and Rutland City Police Department (RCPD).
   These have afforded us the ability to work collaboratively with RCPD to provide recovery support, transportation and admission to inpatient rehab for many people in our community.

# TURNING POINT RECOVERY CENTER of BENNINGTON, VT

 Unhoused Outreach efforts began in Dec '22 and TPRCB now leads a collaborative community team going out twice weekly (includes the Homeless Coalition, Syringe Services & United Counseling). We seek to saturate the community with NARCAN, Harm Reduction and Recovery information, meet them where they're at, and connect folks to resources.



- Secured funding and permits to move ahead with the first Men's Recovery House in Bennington County. (ETA late '24).

- NCVRC collaborated with a local organization (Healthy Lamoille Valley) to capture an Anti-Stigma campaign inclusive of print ads, posters, marketing materials etc...
- The need for Peer Recovery Coaching continues to increase and we fulfilled 850+ recovery coach sessions in FY23.

- Efficiency Vermont is covering 100% of the cost to foam insulate our attic and basement (20k). This will reduce fossil fuels as well as reduce our costs with heating/cooling our building. Reducing our costs will open up flexibility in how we support our guests and staff.
- With the support and effort of RPVT, we were awarded funding to improve our technology and ability to host hybrid meetings. We now have a designated hybrid meeting room have launched two new meetings and have adopted other meetings to now have a hybrid option. Our new meetings are "Women in Recovery" & "LQBTQIA+ Recovery" all peer-led by members of each community in recovery. By the end of the year, we will also be launching a "Men's Recovery" hybrid meeting

 New Program: We have launched our new Offsite Coaching Program (OSC): a unique program that provides recovery coaching services to people in their homes, or other community settings. The program is designed to lower barriers to engaging with coaching and help people achieve their recovery goals and build self-sufficiency.





- Opening our social detox bed! We have had 57 admits and 42 unique admits since we opened November 21, 2022.
- Embedding peer coaches in the high school! We have a fulltime program in the high school, helping youth and young adults learn about substance use and then also stress management, connection and selfesteem.

- In July 2022, we began year one of our three-year pilot program that has transformed our organization. With that as a catalyst, we have grown rapidly including now being one of the largest employers of people in recovery in Vermont.
- During the FY23 fiscal year, we partnered with the Institute for Trauma Recovery and Resiliency (ITRR) to provide clinical services to our residents and launched an Intensive Outpatient Program (IOP) which was eventually opened up to the community.



- We launched and built out a formal workforce development program, hiring our first workforce development and education coordinator.

- We have been strengthening our relationships with local 12 step groups and offering regular groups like Writers For Recovery.

- Arial Beaulac, Program Supervisor

  on the Families Come First
  Prevention Service Act. We hope to
  be able to have recovery coaches
  supporting DCF cases with the
  Parents in Recovery Program
  coaches, in the future, gaining
  increased funding.
- Kingdom Recovery Center is currently partnering with 'Healing Together' Northeast and Regional teams, helping to create wraparound services for those experiencing substance misuse and domestic violence. Arial Beaulac became a trained 'A Window Between Worlds' (AWBW) Art Expression facilitator through this program.



- We have almost reached our fundraising goal to develop our new recovery center facility.
